Sub: Suspension of Membership of NIPM (Membership No. L21100) for the period of 5 years with immediate effect

As decided by the NIPM National Council at its 331st meeting held on 17th June, 2017 at Neyveli, you were issued a Show Cause Notice dated 13th July, 2017, giving you an opportunity to explain your conduct/misconduct as brought out in the said Show Cause notice.

You submitted a written explanation, vide your letter dated 21st July, 2017, to the Show Cause notice. The said explanation and the entire matter were placed before the National Council at its 332nd meeting held on 12th August, 2017 at Bhubaneswar. The National Council considered your explanation and deliberated on the matter. After due deliberation, the Council unanimously passed the following resolution:

“NIPM Life Membership of Shri Asok Khanna (Life Membership No. L21100) is suspended, for the omission/commission as brought out in the enquiry report, for a period of five years with immediate effect under Regulation 9 of NIPM Constitution”.

As such, your membership of NIPM shall remain suspended for the period of 5 years from 23rd August, 2017 to 22nd August, 2022. During the suspended period, you shall cease to be entitled to any benefits and rights of Membership. However, you shall have the right to appeal against the decision to the General Body of the Institute. If you desire so, you shall file a Memorandum of Appeal with the Hon. General Secretary within 60 days of the suspension of this order.

General Secretary recused himself from the deliberation. The NC deliberated on the entire matter of the allegations leveled by Shri Khanna, subsequent enquiry report and show cause notice issued to him. The NC considered the reply of Shri Khanna dated 13th July, 2017.
